E-Statements

We encourage everyone to sign up for home banking. It will give you instant access to balances, loan payments, account transfers and much more.

If you are already using Home Banking we would like to encourage you to sign-up for E-statements. With E-statements you will get your monthly or quarterly statements usually the 2nd day of the month following the statement period. You will receive an email informing you that your statement is ready to view.

E-statements are accessed within the home banking site so there is only one log in.

Are You Ready To Order New Checks?

If you are ready to order or need to re-order checks call us before you do anything else. We are using a new check ordering company that will save our members a nice bit of money. All checks cost the same with this company regardless of the design.



Telephone Fraud (Vishing or Voice Phishing)

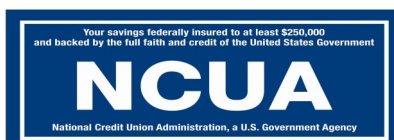
Never give private information, such as your Social Security number, account or credit card numbers, passwords, etc. over the phone unless you initiated the call.

If you receive an automated call or a call from someone claiming to be a credit union employee and they ask for your account information (such as your credit card number, account number, etc.) do not give them any information. Even if the caller has one identifying piece of information (such as your Social Security number), the call is not legitimate. Do not provide any additional account information or any sensitive or personal information. **The credit union will not call you and ask for this information.**

Don't agree to any offer or prize where you have to pay a registration or shipping fee, or send money, to claim the "prize." Don't be pressured to make an immediate decision.
