## E-Statements

We encourage everyone to sign up for home banking. It will give you instant access to balances, loan payments, account transfers and much more.

If you are already using Home Banking we would like to encourage you to sign-up for E-statements. With E-statements you will get your monthly or quarterly statements usually the 2nd day of the month following the statement period. You will receive an email informing you that your statement is ready to view.

E-statements are accessed within the home banking site so there is only one log in.

## Debit Card PIN Numbers

We have heard our members loud and clear. Starting April 16, 2015 we will have the ability to change your PIN numbers in the office.

What that means to you is that if you want us to change your new debt card PIN number all you have to do is call Sue or Arlie in the office and talk to them about what you want to change the PIN access number to. For many of you, this will mean allowing you to have the same PIN as you old ATM Card.

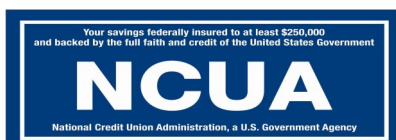
