GLOBAL 1 FCU GOES HIGH-TECH

A number of you may be using **Home Banking** which allows you to look at your balances and make transfers between accounts you are either the primary account holder or a joint account holder on. If you click the "Save a Tree" icon on your main home banking page, you can sign up to have electronic statements which are archived on the site. You will get your statement earlier and it is your option whether to print it out or not. If you need statements down the road, you can access them yourselves right through the home banking website.

We have also launched **Bill Pay** which allows you to set up automatic payments from your account here to your utilities, credit cards and other loan accounts. It also permits you to send funds to another institution and pay funds to another individual. If you are tired of writing checks and paying postage, you will need to register and sign up for Bill Pay. To access it, go to our website at www.global1fcu.com and click on the Bill Pay box, which is located beneath the Home Banking icon.

Our new app for your smart phone offers remote deposit which should be a real convenience for you.

We are expecting to close all of the cards by the end of July. Don't be caught without a working card.

Bill Pay allows you to pick the date you wish to pay each bill and you can determine how much lead time you need because it will specify whether it can send an electronic payment or a check. You can set each payee as a regular recurring payment or set it so that you go in each time and tell it when you want to pay it.

Our newest offering is a free **app for your smart phone**. The app can be found in the app store or the google play store. This app lets you sign into everything with a single 4 digit code and gives you the option of doing "**remote deposits**". You can take a picture of the check you want to deposit and send it to us and it will get credited to your account. It solves deposit problems for those of you at a distance. With Check 21 regulations, we are notified if you try to deposit the same check more than once.


